MEETING MINUTES

1. Welcome words by the Chair

Brian Thomsen (The Chair) welcomed the participants and confirmed the quorum.

2. Adoption of the agenda and approval of the last extraordinary GA minutes (1 February 2023)

The agenda was approved without any change.

The minutes from the previous Extraordinary General Assembly (GA) meeting (February 1, 2023) were adopted without any change.

3. A vision for the future of EU aquaculture

Delilah Al Khudairi (DG MARE) presented the European Commission (EC) views on the future of EU aquaculture. Angelo Kouwenhoven (Dutch Ministry for Agriculture) presented the "Blue Deal" policy in the Netherlands.

The Chair thanked both speakers and the presentations were followed by an exchange of views with AAC Members.

4. AAC activities in 2022-2023

The Secretariat presented the AAC achievements during the past year¹. These included the work of 22 Focus groups and the approval of 10 recommendations (so far).
